



**OFFICIAL RULES FOR “THE SKYGARDEN EXPERIENCE GIVEAWAY” SWEEPSTAKES.  
NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS  
SWEEPSTAKES.**

1. **ELIGIBILITY:** In order to be eligible to participate in the “THE SKYGARDEN EXPERIENCE GIVEAWAY” (“Sweepstakes”), each entrant must be 18 years of age or older as of the start date, and a legal resident of the United States. Proof of eligibility will be required. Employees of Sponsor, CLPF SKY GARDEN HOLDINGS LLC, and their respective parent companies, affiliates, subsidiaries, agents, advertising and promotions agencies, crew members, and any other individual or company involved in the development or execution of the Sweepstakes and their immediate families (parents, siblings, children and their respective spouses) and same households of each, whether or not related are not eligible to enter or win. Participation in any of the Entry Methods outside of the Sweepstakes Period is not valid for entry. 7. **TERMS AND CONDITIONS OF AWARDING PRIZE:** If Winner does not meet any of the eligibility requirements given herein, then a new Winner will be selected in another random drawing. Potential winner must comply fully with these Official Rules and all terms and conditions contained within in order to receive Prize. Failure to comply with anything herein can result in forfeiture of some or all of the Prize. **Prize will be awarded on drawing date as outlined in Section 6 "Selection of Winner".**
8. **OTHER TERMS AND CONDITIONS:** By entering the Sweepstakes, entrant affirms that they have read, understand and accepted these Official Rules.
